Alamo RCD Programs are enhanced through Board Donations of funds, volunteerism and in-kind services. Our Board Secretary/Treasurer provides office space, office supplies, travel expenses, her time and expertise in social network administration, budgeting, grant writing, administrative and program management and fundraising needs. Other Board members also provide expertise and time toward our Senior Assistance Program, Agri-Land Resource Workshop Program and our Growing Rural Garden Program. Alamo RCD believes in collaboration within the communities we serve as we involve local volunteers and partner with local organizations within all of our programs. Local volunteers (over 40 of all ages) provided thousands of hours each toward the success of our mission during 2023 and many local agencies partnered with us toward a major impact within our communities.
